

## BELL'O DIGITAL® PERFORMANCE AND SAFETY RECOMMENDATIONS

- To avoid ear damage or hearing loss, make sure the volume on your music playing device is turned down before connecting your Bell'O Digital<sup>®</sup> in-ear headphones.
  After placing in your ears, gradually turn up the volume until you reach a comfortable listening level.
- Avoid listening at high volume levels for prolonged periods. This may cause permanent ear damage or hearing loss.
- DO NOT insert the headphone so deeply into your ear canal that you feel any discomfort or pain.
- Use Bell'O Digital<sup>®</sup> in-ear headphones responsibly, and be aware of your surroundings. Do not use when it is unsafe to do so, such as: while operating a vehicle, crossing streets at crosswalks, or during any activity or in any environment where your full attention to your surroundings is required.
- Always use the proper size rubber in-ear tip that came with your Bell'O Digital<sup>®</sup> in-ear headphones. Proper fit is essential to performance and safety.
- If desired, slightly *twist* your Bell'O Digital<sup>®</sup> in-ear headphone as you insert it into your ear. This will create a small level of suction and a snug fit that will allow the headphone to remain in place during exercise or other activity.

## LIMITED ONE YEAR WARRANTY

This Bell'O Digital® product, SKU 200, 400, 600, and 700 Series ("Product") is warranted for a period of ONE YEAR from the date of purchase only to the original purchaser ("Limited Warranty"). This Limited Warranty is only valid in the United States of America and Canada. Manufacturer warrants to the original purchaser that the Product is free of defects in material or workmanship for the period specified above. "Defects", as used in this Limited Warranty, is defined as any imperfections that impair the use of the Product. Pursuant to the Limited Warranty, Manufacturer will, at its option. (i) repair or (ii) replace of the Product. This Limited Warranty applies only to use under ordinary consumer use conditions Product is not intended for use under water or in wet or damp conditions. This Limited Warranty does not cover: 1) defects caused by improper installation or disassembly: 2) defects caused by shipping (claims for damage during transit to you should be made immediately by you directly to the transportation company); 3) defects occurring after purchase due to modification, intentional damage, accident, misuse, abuse, negligence, natural disaster, abnormal mechanical or environmental conditions, unauthorized disassembly, repair, modification or exposure to the elements; 4) cosmetic damage; 5) labor or assembly costs; and 6) issues due to commercial use.
