Disc Replacements

Disc Replacements fall under the following two categories:

- In Warranty: Items within 90 days of purchase, or items with a manufacturing defect
- Out of Warranty (\$20 in the U.S., €10 in the Euro Area, or £12 in the U.K. replacement fee): Items beyond 90 days of purchase, scratched discs, or cracked discs

Follow the steps below to submit a Disc Replacement.

- 1. Print out the **Disc Replacement Form** linked below and follow the shipping instructions provided.
- If your disc is Out of Warranty, please include a check or money order for the replacement.
- 3. Please ship using a traceable method.
- 4. Please allow approximately **7-10 days** from the date we receive your item for delivery in North America or Europe.
- 5. Use your **Case Number** when inquiring about your warranty claim.

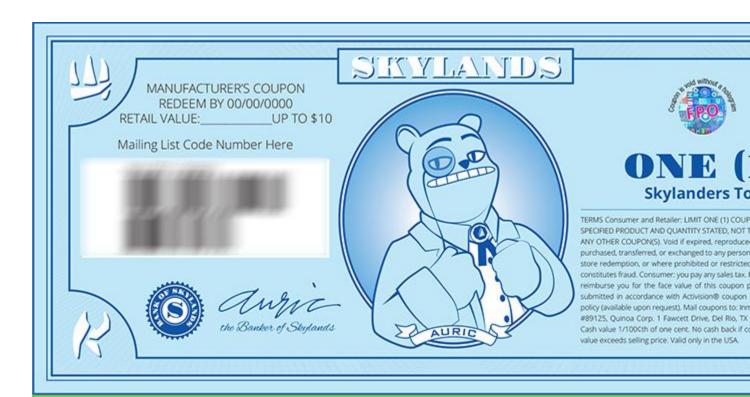

Hardware Replacements

Skylanders Toys using Activision Warranty Vouchers





For select Skylanders toys — usually toys from the most recent Skylanders game — you can request a warranty voucher redeemable for the value of the Skylanders toy you choose in the warranty process. Warranty vouchers are set at values of \$10 or \$15 and are accepted at most major retailers, including Wal-Mart, Toys R Us, and Target. The option to receive a warranty voucher is available through the Warranty form.

1. Select **Warranty** at the top of any page.

- 2. Select Hardware, and then select Skylanders Figures & Toys.
- 3. Enter the Model Number of the Skylanders toy, then select Continue.
- 4. Select Request a Voucher on the Product Information page, then complete the Warranty form.

Warranty vouchers will be mailed to you within 3 business days.

Skylanders Toys Replacements through Activision

Most Skylanders toys are available for warranty replacement, depending on availability.

- 1. Select **Warranty** at the top of any page.
- 2. Select Hardware, and then select Skylanders Figures & Toys.
- 3. Enter the **Model Number** of the Skylanders toy, then select **Continue**.
- 4. Confirm the item you selected, and then complete the Warranty form.

Special Skylanders Toys, Skylanders Portals, and other Hardware Items

Some Skylanders toys and most hardware items must be returned to Activision in order to receive a replacement, including:

- Guitar controllers
- Rare, Legendary, and Alternate Skylanders toys
- Swappable SWAP Force Skylanders toys
- Skylanders portals
- Skylanders Location Items
- Drums
- DJ Decks
- Tony Hawk Boards
- Top Shot Elite Guns
- Fishing Poles
- Kinect Guns

Follow these steps to submit a standard warranty claim:

- 1. Select **Warranty** at the top of any page.
- 2. Select **Hardware**, and then select the appropriate Hardware category:
 - Skylanders Toys Enter the <u>Model Number</u> found on the bottom of the base of the toy, then select **Continue**.
 - Skylanders Portals Enter the <u>Model Number</u> found on the bottom of the Portal, then select Continue.
 - Skylanders Traps Enter the name of the Skylanders Trap, select it from the available options, then select Continue.
 - All Other Hardware Enter the name of the hardware item, select it from the available options, then select Continue.
- 3. Confirm the item you selected, then complete the Warranty form.

If your item is **Return Required**, you will be emailed a **prepaid shipping label** to be used to ship your old item back to us. Please allow approximately **7-10 days** from the date we receive your item for delivery in North America or Europe.

If your item is not **Return Required**, allow approximately **7-10 days** from the date of your warranty request for the delivery of your item in North America or Europe.
