SET UP YOUR FURNITURE PROPERLY

- ☐ Ensure that all parts are assembled properly and fully tightened as per the instructions.
- ☐ When placing in the desired location, ensure that all legs are resting on the same surface. you may adjust the legs levelers as required to ensure that the item stands in a rigid position.

EXAMINE YOUR FURNITURE

- ☐ Examine occasionally to ensure that there are no loose parts. If loose parts are found, they must be retightened fully before additional use.

Warranty

1 YEAR WARRANTY FOR FRAME, RESIN WEAVE AND CUSHIONS WHAT IS COVERED

We warrant to the original purchaser for one year, from the date of purchase, that the frame, resin weave and cushions will be free from manufacturing defects. This warrant also covers peeling, crackling, blistering, discoloration, or fading for this one year period.

WHAT IS NOT COVERED

It remains the customer's responsibility for freight and packaging charges to and from our service center. This warranty does not cover commercial use, acts of nature, fire, freezing, and abusive use. Discoloration or fading of the finish or fabrics as a result of chemicals or spills is not covered. Glass tabletop breakage and corrosion or rusting of hardware are not covered. In addition, purchased parts are not covered under this warranty. Proof of purchase (dated register receipt) is required for warranty claims. We reserve the right to make substitutions with similar merchandise, if the model is no longer in production. Warranty is to the original purchaser and is not transferable. As some states do not allow exclusions or limitations on an implied warranty, the above exclusions and limitations may not apply. This warranty gives you specific rights, and you may also have other rights, which vary from state to state.

WARRANTY

This limited warranty is extended to the original purchaser and applies to defects in material and workmanship of your Patio furniture, provided your furniture is maintained with care and used only for personal, residential purposes.

Resin wicker is warranted to be free from defects in material or workmanship for a period of one (1) year.

Warranty

Cushions are covered for a period of one (1) year against defects in material or workmanship.

Frames are warranted to be free from defects in material or workmanship for a period of one (1) year.

Exclusions: items used for commercial, contract, or other non-residential purposes, or items damaged due to acts of Nature, vandalism, misuse, or improper assembly is not covered. Discoloration and fading of the finish or fabrics as a Result of chemicals or spills are not covered.

Glass table top breakage and corrosion or rusting of hardware is not Covered. If, within the stated warranty period, this product is found to be defective in material or workmanship, the Purchaser must contact the customer service department at 1-800-327-2978. The manufacturer, at its option, will repair Or replace the defectives parts. Proof of purchase (date register receipt) is required for warranty claims. Care and Maintenance

- ☐ Wash the frame with a mild solution of soap and water, rinse with clean water, and dry thoroughly.
- ☐ Cushions may also be cleaned by hand with a mild solution of soap and water. Rinse the cushion cover thoroughly and allow to drip dry. The back cushion and pillow should be spot cleaned with a soft cloth. Do not machine wash or tumble dry, as cushions may shrink. Do not use bleach or solvents on fabrics. Never use cleaners that contain acid or abrasive Materials.
- ☐ Use and operation: To improve the life span of this furniture, cover when not use and store in a dry place in the off season.

PLANNING ASSEMBLY

To prevent damage, place all parts on a soft surface during assembly. Remove all protective caps before beginning assembly. It takes about 90 minutes for two person to complete all the assembly.

Assembly Instructions

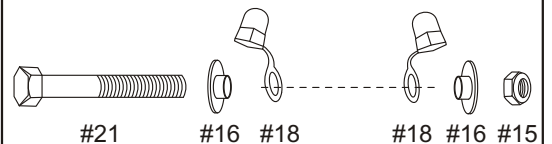


1. Bring the top end of leg tube #3-L and #2 together using two hardware sets A. Do not tighten the bolts and nuts. Repeat for the other side #3-R. Attach tube #1 at both ends to top end of leg tubes #2 and tighten the bolts and nuts. (See Fig. 1)

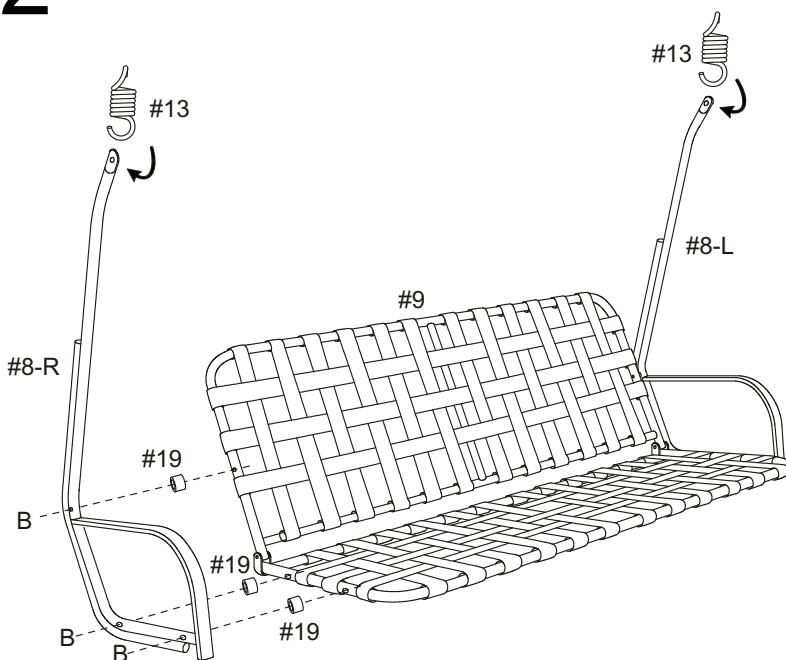
2. Attach rod #5 to leg tube #3-L and #2 using two 50mm bolts #24 and two nuts #17. Attach tube #4 to leg tube #2 using two 80mm bolts #23 and two nuts #17. Repeat for the other side. (See Fig. 1)

3. Use four plastic plugs #12 to four leg tubes end.

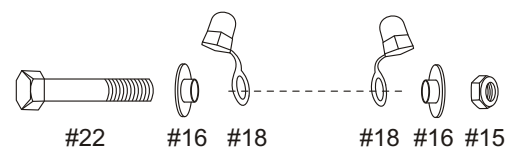


1. Open seat and back #9. Attach arm #8-R to seat frame using two hardware sets B and two plastic washers #19. Attach arm #8-R to back frame using a hardware set B, and a plastic washer #19. (See Fig. 2)

2. Hook spring #13 at the top of arm #8-R.

3. Repeat for the other arm #8-L.

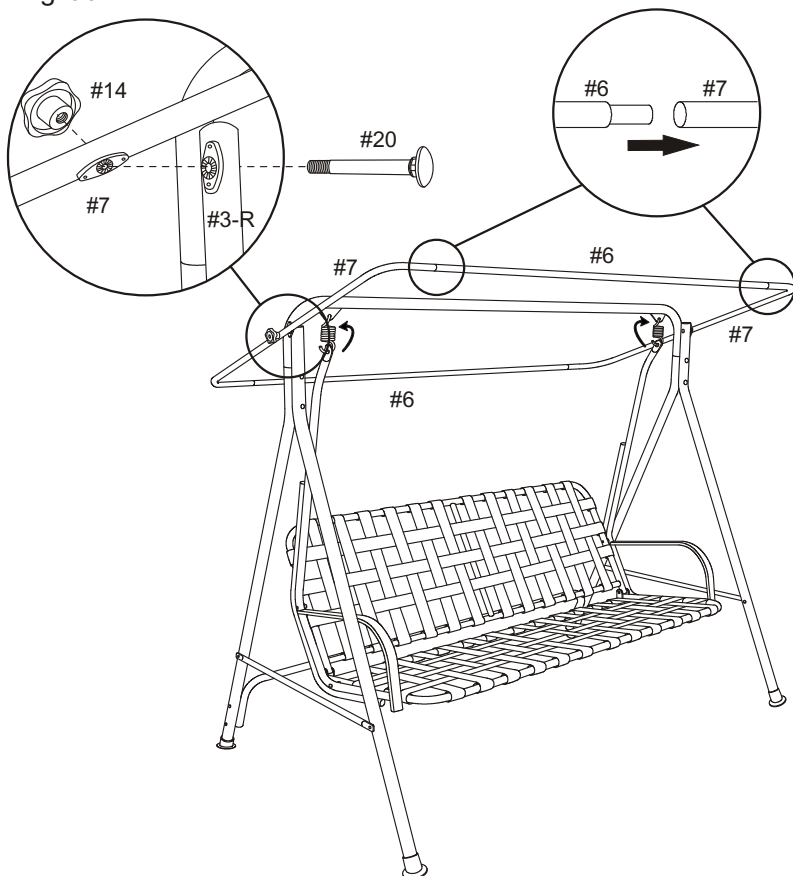
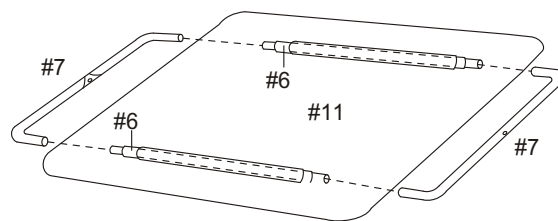


Fig. 3a: CANOPY ASSEMBLY



1. Insert tubes #6 into the sleeves of the canopy cover #11. Insert both tubes #6 into ends of tube #7. (See Fig. 3a).
2. First, attach a tube #7 on to the main frame using a 95mm bolt #20 and a knob #14 to connect with top end of leg tube #3-R, and then insert two tubes #6 into ends of tube #7. Finally attach other tube #7 to tubes #6 and using a 95mm bolt #20 and a knob #14 to connect with top end of leg tube #3-L. (See Fig. 3b)
3. Hang the seat assembled on both sides to the corner bracket of tube #1 using the hooks #13. (See Fig.

1. Attach canopy cover #11 on to canopy frame using straps to around the tubes #6 and #7. (See Fig. 4)
2. Place the cushion #10 on the seat frame and using straps to around the back frame.

Your swing is now ready to use.
