## INNERSPACE 15 Year WARRANTY

InnerSpace Luxury Products, LLC ("InnerSpace") warrants that the core of this InnerSpace® Mattress shall be free from manufacturer's defects in material and workmanship for 15 years from the date of purchase. If a defect in the core of the mattress is observed during the warranty period, InnerSpace will replace the mattress containing the defective core within the fifteen year warranty period. A new warranty shall not apply to any replacement mattress; however, the unexpired term of the original warranty will apply to any replacement mattress. If a mattress identical to the one originally purchased is not available at the time a replacement is awarded, InnerSpace will remanufacture a mattress to meet the same specifications as the original mattress. This warranty is applicable only to the initial purchaser and does not apply to mattresses sold by InnerSpace and used for purposes other than human sleeping. This warranty does not cover damage to the mattress caused by, including, but not limited to, use of an inappropriate bed frame, springs or foundation, soiling, odor, burns, tears, cuts, stains, water, urine, bodily fluids, pets, abuse, improper maintenance, ordinary wear and tear and similar use or damage. This warranty applies only to the mattress core. InnerSpace does not warrant that its mattress is suitable for any purchaser's medical or other condition.

ANY IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, RELATING TO THE MATTRESS CORE SHALL NOT EXCEED THE TERM OF THIS WARRANTY. EXCEPT AS STATED ABOVE, INNERSPACE MAKES NO REPRESENTATION OR WARRANTY OF ANY OTHER KIND, EXPRESS OR IMPLIED, WITH RESPECT TO THE MATTRESS, WHETHER AS TO MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR ANY OTHER MATTER; ANY SUCH WARRANTIES BEING HEREBY EXPRESSLY EXCLUDED. THE REMEDIES SET FORTH IN THIS WARRANTY ARE EXCLUSIVE REMEDIES AND ARE IN LIEU OF ALL LIABILITIES OR OBLIGATIONS OF INNERSPACE FOR DAMAGES TO OR BY THE INITIAL PURCHASER OR ANY THIRD PARTY. IN NO EVENT SHALL INNERSPACE BE RESPONSIBLE OR LIABLE FOR ANY SPECIAL OR CONSEQUENTIAL DAMAGES (INCLUDING; BUT NOT LIMITED TO, LEGAL EXPENSES) RESULTING FROM ANY CLAIM REGARDING THIS WARRANTY OR THE USE OF MATTRESSES SOLD BY INNERSPACE, EVEN IF INNERSPACE IS ADVISED OR KNOWLEDGEABLE OF THE POSSIBILITY OF SUCH DAMAGES OR COSTS.
