

## **TEXSPORT TENTS:**

### **1 Year Warranty**

#### **LIMITED WARRANTY**

Texsport warrants to the original consumer purchaser that this tent is free from defects in materials and workmanship for a period of one (1) year from the date of purchase. All implied warranties relating to this tent, including, without limitations, the warranties or merchantability and fitness for a particular purpose, are also limited in duration to one (1) year from the date of purchase. Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. This warranty extends to the original consumer purchaser only and does not extend to subsequent purchaser or other transferees. This warranty does not cover cost of shipment to Texsport; normal wear and tear, including discoloration or fading from use or over exposure to sunlight; damaged fiberglass poles; damage caused by misuse, abuse, neglect, alterations, repairs by unauthorized persons, negligence or inclement weather conditions (i.e. hurricanes, tornadoes, thunderstorms, wind storms), or other acts of nature; tents sold outside of the United States, Puerto Rico, Virgin Islands, Guam, or American Samoa; tents used for commercial purposes or in profit or non-profit instructional or rental operations; and it is the sole express warranty relating to this tent.
