

## LIMITED WARRANTY

Winplus North America warrants to the original owner-user that Windex™ Exceptional Performance wiper blades will be free from defects in material or workmanship for up to one year from the date of purchase.

## LIMITATIONS AND EXCLUSIONS

Winplus North America's obligations under this warranty and the sole remedy for its breach are limited to the replacement of wiper blades which prove to be defective. All returns of defective wiper blades must be made through Winplus North America, Inc. Customer Service (866-294-9244).

1. The warranty provided herein does not cover charges for labor or other costs incurred in the replacement of wiper blades.
2. All claims under the warranty provided herein must be made within thirty (30) days from the date of discovery of the defect. Failure to notify Winplus North America of a warranted defect within thirty (30) days of its discovery voids Winplus North America's obligations hereunder.
3. The warranty provided herein shall be void and of no effect in the event that (a) the wiper blade has been subjected to misuse, neglect or accident; (b) modifications are made to the product; (c) the product is not installed in compliance with the manufacturer's printed instructions.
4. THE WARRANTY PROVIDED HEREIN IS FOR REPLACEMENT ONLY. Winplus North America shall not be liable for any loss, cost, damage, or expense of any kind arising out of a breach of the warranty. Further, Winplus North America shall not be liable for any incidental, consequential, exemplary, special, or punitive damages, nor for any loss of revenue, profit or use, arising out of a breach of this warranty. In no event will Winplus North America be liable for any amount greater than the replacement of a defective wiper blade. The disclaimers of liability included in this paragraph 4 shall remain in effect and shall continue to be enforceable in the event that any remedy herein shall fail of its essential purpose. Some states may not allow the exclusion or limitation of incidental or consequential damages, so that exclusion may not apply to you. This Limited Warranty gives you certain legal rights. You may have other rights that vary from state to state.
