Component parts and accessories are warranted for a period of one (1) year from the date of purchase. Any warranties from suppliers of component parts supersede KL Industries' warranty.

CLAIMS PROCEDURE

The return of any KL Industries boat will not be accepted without a return authorization number. The retailer can obtain this number by contacting our Customer Service Department.

Any claim under this warranty must be communicated via our website at www.sundolphin.com. Please have the following information available: model, serial number, proof of purchase and photos of the defect. KL Industries will evaluate the information and determine if it is a valid manufacturing defect prior to issuing a return authorization number.

KL Industries reserves the right to discontinue and make changes in any of its products. In the event that products covered by this warranty are not available, KL Industries shall have the right to substitute products that in KL Industries sole discretion are of comparable grade, quality or price.

EXCLUSIONS AND LIMITATIONS

This warranty does not cover:
