

LIMITED WARRANTY

A new or reconditioned Net10 is covered by a one year limited warranty, set forth below, administered by Net10. Net10 accessories have a 90-day limited warranty against defects in materials and workmanship under normal use by the purchaser.

How to obtain Warranty Service. To obtain warranty service from Net10 on a new or reconditioned phone or Net10 accessories, please contact Technical Support at 1-800-867-7183. If your problem cannot be resolved over the phone, our Net10 technicians will provide you with a Ticket Number, which you will use to send your phone and/or accessories to the designated Net10 Service Center for repair or replacement, at Net10's discretion.

Terms of Limited Warranty. Net10 warrants to you, the Customer, that your Net10 ("Product") is free from defects in material and workmanship that result in Product failure during normal usage, according to the following terms and conditions:

- (1) The limited warranty for the Product extends for one (1) year beginning on the date of the purchase of the Product.
- (2) The limited warranty extends only to the original purchaser ("Consumer") of the Product and is not assignable or transferable to any subsequent purchaser or end-user.
- (3) The limited warranty extends only to Consumers who purchase the Product in its original packaging from an authorized dealer.
- (4) During the limited warranty period, Net10 will replace or repair, at Net10's sole option, any defective Products or parts (except as excluded below), or any Products or parts that will not properly operate for their intended use (except as excluded below) with new or refurbished replacement Products or parts if such replacement or repair is needed because of Product malfunction or failure during normal usage. Net10 may, at its sole discretion, replace the Product with a refurbished phone of the same model if available, or if not available, of a comparable model. The limited warranty does not cover loss of personal information, passwords, contacts, music, ringtones, pictures, videos, applications or other content, memory cards, software, defects in appearance, cosmetic, decorative or structural items, including framing, and any non-operative parts. Net10's limit of liability under this limited warranty is the actual cash value of the Product at the time the Consumer returns the Product to Net10 for repair. determined by the price paid by the Consumer for the Product less a reasonable amount for usage and depreciation. Net10 shall not be liable for any other losses or damages. These remedies are the Consumer's exclusive remedies for breach of this limited warranty.
- (5) Upon request from Net10, the Consumer must prove the date of the original purchase of the Product by a dated bill of sale or dated itemized receipt.
- (6) The Consumer shall have no coverage or benefits under this limited warranty if any of the following conditions are applicable:
- a) The Product has been subjected to abnormal use or conditions, improper storage, exposure to moisture or dampness, unauthorized modifications,

connections or repairs, misuse, neglect, abuse, accident, alteration, improper installation, or other acts which are not the fault of Net10, including damage caused by shipping. b) The Product has been damaged from external causes such as collision with

- an object, or from fire, flooding, sand, dirt, windstorm, lightning, earthquake or damage from exposure to weather conditions, an Act of God, or battery leakage, theft, blown fuse, or improper use of any electrical source, damage caused by computer or internet viruses, bugs, worms, Trojan Horses, cancelbots or damage caused by the connection to other products not recommended for interconnection by Net10.
- c) Net10 was not advised in writing by the Consumer of the alleged defect or malfunction of the Product within fourteen (14) days after the expiration of the applicable limited warranty period.
- d) The Product serial number plate or the enhancement data code has been removed, defaced or altered. e) The defect or damage was caused by viruses or other software problems
- introduced into the Product. (7) Net10 does not warrant uninterrupted or error-free operation of the Product or
- Service.
- (8) Net10 EXPRESSLY DISCLAIMS ANY IMPLIED WARRANTY OF
- MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE OR USE. THE FOREGOING LIMITED WARRANTY IS THE CONSUMER'S SOLE AND
- EXCLUSIVE REMEDY AND IS IN LIEU OF ALL OTHER WARRANTIES.

(11) This is the entire warranty between Net10 and the Consumer, and supersedes all prior and contemporaneous agreements or understandings, oral or written, relating to the Product, and no representation, promise or condition not contained herein shall modify these terms.
