



#### Limited Warranty

Kittrich LLC dba Vantage ("Vantage") warrants to the original owner-user that this product will be free from defects in material or workmanship. This warranty is limited to twelve (12) months, and begins from the date of purchase (original purchase receipt required), whether or not actual use begins on that date, or twelve (12) months from date the product was shipped by Vantage to the retailer or individual purchaser, whichever occurs first.

#### Limitations and Exclusions

Vantage's obligations under this warranty and the sole remedy for its breach are limited to repair, at its manufacturing facility, of any part or parts of its warranted products which prove to be defective; or, in its sole discretion, replacement of such products. All returns of defective parts or products must include the product original packaging with UPC, accompanied by the original, dated purchase receipt, and must be made through an authorized Vantage product distributor or arranged through Vantage Customer Service. Authorized returns must be shipped prepaid. Repaired or replacement parts will be shipped by Vantage F.O.B. shipping point.

1. The warranty provided herein does not cover any costs incurred or associated with removing the product from the Customer's location, or preparing the product for return.
2. All claims under the warranty provided herein must be made within thirty (30) days from the date of discovery of the defect. Failure to notify Vantage of a warranted defect within thirty (30) days of its discovery voids Vantage's obligations hereunder.
3. The warranty provided herein shall be void and of no effect in the event that Vantage has determined, in its sole and absolute discretion that (a) the product has been utilized outside its design specifications; (b) the product has been subjected to misuse, neglect, accident, improper or inadequate maintenance, or corrosive environments, (c) modifications or alterations are made to the product; (d) the product is not installed or operated in compliance with the manufacturer's printed instructions; (e) the product was placed or utilized in an environment not conducive for products of this type (i.e., dirt or rocky substrate, heated surfaces, chilled surfaces, flexible surfaces, etc.).
4. The warranty provided herein is for repair or replacement only. Vantage shall not be liable for any loss, cost, damage, or expense of any kind arising out of a breach of the warranty. Further, Vantage shall not be liable for any incidental, consequential, exemplary, special, or punitive damages, nor for any loss of revenue, profit or use, arising out of a breach of this warranty or in connection with the sale, maintenance, use, operation or repair of any Vantage product. In no event will Vantage be liable for any amount greater than the purchase price of a defective product. The disclaimers of liability included in this paragraph 4 shall remain in effect and shall continue to be enforceable in the event that any remedy herein shall fail of its essential purpose.

VANTAGE SPECIFICALLY DISCLAIMS ALL OTHER EXPRESS AND IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IN THE EVENT LOCAL LAWS LIMIT WARRANTY DURATION, DURATION OF THIS WARRANTY SHALL BE LIMITED TO THE MINIMUM PERIOD REQUIRED BY LAW. NO WARRANTIES APPLY AFTER THAT PERIOD. No person or entity is authorized to bind Vantage to any other warranty, obligation or liability for any Vantage product. Installation, or use of the Vantage product for which this warranty is issued shall constitute acceptance of the terms hereof.
