## Warranty Statement

UNIREX provides a: Five (5) years for SD/MicroSD Two (2) years for USB

Limited warranty for all of its products sold in the United States. Warranty is in affect from the date of purchase against defects in materials under normal use.

UNIREX agrees, at its option under the warranty, to repair or replace the product with no charge, if it is determined to be defective. The warranty does not cover cosmetic damage, water damage or damages due to line power surges, connection to improper voltage supply or settings.
