The warranty does not cover cosmetic damage, AC cords, or damage due to line power surges connection to improper voltage supply setting, damage caused by leaking batteries, misuse, mishandling, improper application, accident acts of God, or attempted repair by an unauthorized service agent.

In order to have your merchandise repaired or replaced by warranty, you must return the product Freight Prepaid to the address below within the duration of the warranty. With the return of the product, you MUST includes

- Proof of purchase which must have a purchase date that falls in the warranty period specified in the warranty card.
