Optimus enterprise, Inc, warrants to its customers and/or consumers of this Humidifier and the parts thereof will be free from defect in material and workmanship, under normal use, for a period of one (1) year from the date of initial purchase. The warranty does not apply to repairs necessitated by damage, misuse, abuse or alternation and to any repairs of merchandise not used within the United States unless otherwise prescribed my law. Optimus enterprise, Inc, shall not be liable for any personal injury, property damage or any incidental or consequential damages of any king (including water damage) resulting from malfunctions, defects, misuse, improper installation or alternation of this product. This warranty is the only warranty extended by Optimus Enterprise, Inc, to its original customers and/ or consumers purchasing fan, Optimus Enterprise, Inc, disclaims all other warranties, expressed or implied, that arise by the operation of law, specifically including the implied warranties of merchantability and fitness for a particular purpose. Optimus Enterprise, Inc, shall not be liable for any incidental or consequential damage, which may have resulted from any alleged breach of warranty. Should the fan fail during the warranty period, the owner should:

Within the first 12 months from date of purchase, Optimus Enterprise, Inc, will repair or replace the product if it is defective in material or workmanship providing it is returned to Optimus Enterprise, Inc, with freight prepaid, with evidence of purchase date (cash registered receipt) together with fee check or money order for handling and return packaging/ shipping charges.
